"Reclaiming the Median"

James Alfandre. an alum of the MRED program, is a pioneer in his new home of Salt Lake City. Notorious for its wide streets, Salt Lake City has had serious challenges to becoming a walkable city. James, however, saw these wide streets not as barriers to urban redevelopment, but as the focal points. Alfandre worked with city officials to develop the median of these large boulevards to host pop-up restaurants, retail, events, and concerts. "We're changing the economics of the street," Alfandre says. "Before, the streets sucked resources to be maintained, and now the streets are generating new tax revenues, jump-starting local businesses and catalyzing new investment in adjacent properties."
