MAPP Travels to Haiti

RDEV staff member, **Gérard Boulin**, traveled to Haiti with MAPP student group -- President and Vice President, **Brian Houstle** and **Nicholas Przybocki** of Roots Home & Abroad. **Boulin** served as a consultant, and language and cultural interpreter to foster local connections in Haiti. In addition to tasting amazing food, dancing to Haitian music, and seeing colorful art, they began a relationship with the community of Léogane. Together with the mayor, they met with community members to discuss public issues including the need for clean water, electricity, bathrooms, and communal amenities. After identifying the key issues, they met with a construction company, engineer, architect, and business leaders to gain advice and insight into the construction process in Haiti. In six months, they will return to meet with the community and propose their sustainability concept design.

Houstle stated, "On Saturday we traveled to Léogane. We met with the Mayor who discussed a partnership with us and invited us to their community meeting. At the meeting, we met the thirteen district representatives of Léogane. They spoke about their lack of electricity, their poisoned waterways and flooded croplands. However, they also spoke of their community pride for their major yearly Easter event, RARA, their patience to work together, and their multipurpose space connected to the high school in the center of the city. The space is used for teaching their children, but many of the district representatives expressed concern about the location of the public buildings. The districts located in the mountains receive less support, and have poor access to the pleasantries of the city center. We believe our project may be the opportunity to provide communal amenities directly to these districts."

OBITUARY: ROBERT SAMUEL KENISON

It is with great sadness that the Colvin Institute announces the passing of

our friend and former faculty member, Robert Kenison.



Robert Samuel Kenison, 79, of Arlington, VA, passed away on June 13, 2018 after a brief illness. Born July 11, 1938 in Evanston, IL to Samuel Morris Kenison and Gertrude Kenison (née Sullivan), Bob was raised in Manchester, NH. He graduated summa cum laude from St. Anselm College in Goffstown, NH in 1960, and from The Harvard Law School in 1963. After law school, Bob joined the Peace Corps, and the experience changed his life. He served

for two years in a poor barrio in the city of Manizales, Colombia. He met his wife-to-be, also a Peace Corps Volunteer in Manizales, and established lifelong friendships. Living and working in a desperately poor community, he came to believe that there was a role for government in helping the poor, especially in a society where the rich get richer and the poor get poorer. Bob pursued a career born of this experience, serving with distinction as an Associate General Counsel in the U.S. Department of Housing and Urban Development. In his forty-plus years of public service, he earned the friendship, respect and admiration of many, and won numerous awards. Bob was the only HUD official to have three times received the President's Rank Award, under Presidents Reagan, Bush, and Clinton. In retirement, he was an adjunct faculty member at the University of Maryland's Colvin Institute of Real Estate Development. More than ten years after his retirement, he received yet another award, from a forum of the American Bar Association, for outstanding service and commitment to affordable housing and community development law. Bob is survived by Anne, his beloved wife of 52 years; his daughter Laura; son-in-law Colin; brother Paul; nieces Tracy and Dale and their families; many cousins and friends, as well as Anne's sister Debbie and mother Rose, now 102. He was predeceased by his parents, both of whom died too young, and his brother Arthur, known to family as Ralph, who died in 2017, five years after the devastating loss of his wife Jeanne. Bob, who loved reading, golf, jazz, travel, and work, will be remembered for his keen intellect, sense of humor, integrity, commitment to public service, and love for his family. At Bob's request, there will be no funeral.
