#### **Summary Description:**

The Four Square duplex quarter is a frame, one story building with a garret, covered by a side-gable roof and horizontal wooden siding (both modern replacements), supported by brick piers, with a central brick chimney that is largely collapsed. The two first floor rooms are accessed via single doorways centered in their bays on the west facade, with single windows in each bay in the opposite wall, and in each end wall. An enclosed stair is located in the southwest corner of the south room, providing the only access to the garret. The garret appears to have been divided into two rooms at the chimney stack. No stair currently exists to provide access to the garret above the north room, but evidence in the framing suggests that a second stair was located in the northeast corner of the space. In addition to the collapsed chimney/fireplace, a structural post in the east wall has failed, causing the adjoining wall section to deflect, and in turn resulting in considerable additional deterioration to the siding and to structural members. The structure is located 168 feet from the SW corner of the building to the NE corner of the shed addition of the main house at 220°.

Abundant structural evidence exists to suggest that the duplex was created during two phases of construction, with the second phase likely the result of moving and appending an existing structure (now the north bay) to the original cabin (south bay). The results of dendrochronological testing confirm this hypothesis, as the findings indicate that the south bay was erected circa 1789 and that the north bay was built circa 1830.


Upton (1982) hypothezised an original construction date of circa 1810 for the quarter,

primarily based on the ascribed date of 1807 for the nearby main house. He recognized that the existing structure was the result of two building phases, further hypothesizing that the addition dated to the second quarter of the 19th century. The dendrochronological results therefore support Upton's assessment of the general timing of the construction of the second bay, but also indicate that the Period I portion of the building was erected considerably earlier than had been suggested. That the single-cell quarter may have been constructed almost 20 years earlier than the main house raises the question whether the building originally served as an outlying quarter, or whether it was related to an earlier farmstead. At least one of the corner posts in the Period I portion appears to have been repositioned, which at least raises the possibility that the structure was built of reused material. As with the repositioned post (it has been inverted), other framing elements located along the north wall of the Period I cabin appear to have been altered, possibly to accommodate joining the two existing structures; no other timbers exhibit any evidence of having been reused. It may have been necessary to adjust the roof pitch of the original structure to match the addition, as well, as short pieces of wood were found attached to the feet of each of the rafters there, which may have served to raise the roof slightly.


#### Period: I

- --Stair location appears to be original, but changed from ladder to winder: waisted outrigger in stair opening appears original, to bear false plate; but stud inserted to act as post for stair no M&T, nailed at top with hand-headed nails, and notched to fit around corner brace. Original window closed to accommodate enlarged stair? Stair trim attached with machine-headed nails.
- --All stud cripples nailed to braces using hand-headed nails.
- --North end girt lapped over plate w/half-dovetail.
- --Dist. from floor to bottom of collar mortise: 6' 9".
- --Ev. of whitewash in garret.
- --Much of sill on long side, front, replaced w/circular sawn; sill on rear deteriorated.
- --Ev. of plaster lath (rectangular nail holes) on first floor side walls; remnants of circular sawn siding.
- --NW corner brace (with empty mortises) nailed to corner post at M&T with round nails.

- --Sills jointed with mortise and tenon: end sills with tenons, sides with mortises.
