Dr. Jourdan founded the Academic Advisory Council for Signage Research and Education and edited the Interdisciplinary Journal of Signage and Wayfinding. Research

Trained as both a lawyer and a planner, my research agenda has developed as a reflection of my interdisciplinary education through two primary trajectories. The first line of my scholarship examines the role of citizen participation in reducing the grief effects experienced by those displaced from public housing as a result of redevelopment activities. My secondary area of research focuses on the legal aspects of zoning with an emphasis on demonstrating how planning and legal principles may be utilized to solve "wicked problems."

My primary research agenda centers on the relationship between federal housing policy and changing role of resident participation in decision making, with a special emphasis on the effects of relocation on resident stability. More specifically, I examine the factors and practices which contribute to or decrease the effects of relocation grief (Kleinhaus, 2003; Rubenstein, 1988; Fullilove, 2001; Rohe and Mouw, 1991). This work began with an intensive two-year study of the HOPE VI motivated relocation process for the public housing residents at McDaniel Glenn in Atlanta, Georgia. Funded in part by an Early Dissertation Research Grant from the United States Department of Housing and Urban Development, my findings were published in the International Journal of Public Participation (Jourdan 2008) and the Journal of the Community Development Society (Jourdan 2008). My research demonstrates that involvement of residents of public housing, including children, in the decision-making process reduced relocation grief. With colleagues Van Zandt and Tarleton (2013), we showed that relocation grief can also be lessened by promises for return to the community upon reconstruction. Later work, funded as a part of a MacArthur Foundation Grant to the University of Florida's Shimberg Center and published in the Journal of Housing and Community Development Law (Jourdan, Ray, and Thompson 2014), showed the impacts of relocation on residents of subsidized housing in Florida that were being displaced as a result of the conversion of units to market rate. Working with a team of lawyers, I examined the value a court might ascribe to damages suffered as a result of relocation-related grief, as published in the University of Florida's Journal of Public Policy (Jourdan and Feinberg 2010). No longer funded, the HOPE VI program modified the lives and landscapes of cities across the nation. In both the Journal of Planning Research and Education (Jourdan 2014) and the Journal of Historic Preservation Education and Research (Jourdan and Pilat 2014), I have published studies of the importance of the loss, from the perspective of historic preservation, of these archetypes of housing. This subject has become increasingly important to the national dialogue related to housing the poor due to federal policies which seek to eradicate traditional public housing structures, erasing this physical reminder of housing for the poor from the urban landscape.

Over the past ten years, I have built on my expertise related to participation and relocation grief in other contexts involving planning for climate change. Concerns about the ways in which sea level rise will lead to the displacement of coastal populations led me to join forces with Dr. Kathryn Frank, Assistant Professor of Urban Planning at the University of

Florida, to engage in two large scale action research projects related to sea level rise in northern Florida. Funded through grants from the National Oceanic and Atmospheric Administration and Florida Sea Grant, I devised and implemented a participatory process that brought together local stakeholders over the course of three years to begin planning for local adaptation to sea level rise. This project involved a true integration of science and planning, engaging staff at the Guana Tolomato Matanzas Reserve and a steering committee of local citizen experts in the design and implementation of a planning process that resulted in the creation and empowerment of a group of citizen experts to champion This process involved the use of traditional and on-going planning activities. non-traditional participatory techniques that have garnered significant attention in the planning and climate change realms and was prominently feature in the 2015 issue of Landscape Architecture Magazine, specifically the use of role playing activities and land use games to allow citizens to actively understand and engage in planning for adaptation. The first in a long line of articles from this project is now under review by the Journal of Planning Education and Research (2016).

The opportunity to work with Indigenous people in Oklahoma on issues related to climate change has provided an opportunity to use my expertise to serve another displaced population. There is a very small community of planning scholars studying or planning This work is critical to climate scholarship as indigenous with these communities. knowledge embraces many of the principles necessary for long term sustainability and resiliency. In three short years, I have participated in two tribal master planning processes: Rosebud Reservation and Pawhuska Indian Village. The Rosebud Master Plan received a national SEED award from Design Corps in 2015. In addition, I received funding from the Bureau of Indian Affairs to complete five vulnerability assessments for tribes in the region: Kaw Nation, Otoe Missouri Tribe, Wichita and Affiliated Tribes, Fort Sill Apache Nation, and the Citizen Potawatomi Nation. I simultaneously received funding from the Chickasaw Nation to host a drought planning workshop to engage stakeholders in helping to envision strategies they would support regarding water use. With my team, a game was devised to help participants make decisions about the most important strategies given constrained resources. I continued the work with indigenous persons at Texas A&M University. As a member of the Indigenous People's Working Group, I have been involved in programming events to bring attention to issues important to indigenous people. interdisciplinary team, I have received a small seed grant to envision the utilization of the land grant mission as a form of reparations for descendants of Native peoples who were displaced from the region where Texas A&M sits by the Morrill Act.

Recently, I have had the opportunity to return to the roots of my scholarship. When I began my doctoral studies, I was interested in the rights of young people in local decisionmaking. My early publications contemplated the abilities of young people to engage with adults as intergenerational partners in decisionmaking. Over the years, I worked to connect my scholarship to the principles included in the United Nation's Convention on the Rights of the Child. In response to the global outcry for climate action by youth, this work has taken on new meaning. I recently published an article on the role of protests and litigation by young people in shaping future climate policy. This article, published in the *International Journal of Sustainable Tourism*, has resulted in a request by

a publisher for a book on the same topic. I am in the final stages of completing the proposal for a book. This book seeks to chronicle the impact of youth activism across globe as a means of urging legislators to take action to reduce carbon emissions through lawsuits against governments by youth groups and also youth protests of government inaction.

Legal Aspects of Zoning

Urban planners are enabled to do the work of land use planning as a result of State and Federal rules that govern the development of the built and natural environments and their inhabitants. I have been teaching planners about the principles of land use law since I began my academic career. Over the years, I have developed a pedagogy that teaches both principles and application, providing students real world opportunities to practice applying the law to planning issues. For more than a decade, I struggled to find a textbook that matched my pedagogical style. To address this gap, I co-authored a textbook. Planning for Wicked Problems: a Planner's Guide to Land Use Law, published last November (Jourdan and Strauss 2015), is now finding its way into planning classrooms across the country. This academic textbook provides a meaningful opportunity for planning students to fully appreciate the nature of land use law issues and the solutions—both good and bad-emanating from the complexities of the relationship between law and the This approach is a reflection of my pedagogical style and a true reflection environment. on the power and limitations of the law to assist in crafting local policies, plans, and ordinances that promote planning which balances the public interest with private property rights.

Teaching

During my years in legal practice I became acutely aware of the high level of conflict existing between planning staff and city attorneys. A desire to better understand the roots of this conflict and work to address inspired me to undertake doctoral studies in planning and ultimately to use my expertise in planning and law in the classroom. As an educator I seek to train the next generation of planners and lawyers to be better aware of the important overlaps between these two fields and understand how the tools of each discipline can be activated to make positive change. Utilizing a project based approach, I seek to utilize my classroom as a place to engage interdisciplinary students in understanding and practicing the ways in which their academic experiences are useful in developing policy.

Over the past 12 years, I have developed eleven new classes, offered at both the undergraduate and graduate levels. These include: Planning History and Theory, Introduction to Planning, Land Use Law, Historic Preservation Law, Historic Preservation Seminar, Research Methods for Sustainability, the Sociology of Housing, Growth Management Law, Growth Management Seminar, Housing Law, and Global Cities. In every course, I have received teaching evaluations, which exceed college and divisional norms. I have received teaching awards from Texas A & M's College of Architecture and the University of Florida's Department of Urban and Regional Planning.

In the majority of my courses, I seek to engage students in the application of principles learned to planning practice. This work has twice been honored with awards from the Texas and Florida chapters of the American Planning Association. Texas APA issued an outstanding student project award to an interdisciplinary project between students in planning and tourism for their historic and cultural inventory of Hearne, Texas. Florida APA gave a similar award to students in both planning and law at the University of Florida who worked with planning staff from Pinellas County, Florida to create a series of post-disaster planning ordinances. These ordinances, while selectively referred to as post-disaster planning activities, were some of the first sea level rise planning activities in the State of Florida. These projects are a testament to a pedagogical process that seeks to cross-train an interdisciplinary array of students to understand the value of voices and perspectives in the planning and development process.

I have served as the chair or a member of more than 100 thesis committees and doctoral committees during this period.

Service

Between 2016-2021, I served as Executive Associate Dean for the College of Architecture at Texas A&M University. In that capacity, I manage a team of Associate and Assistant Deans, Department Heads, Center Directors and Staff who serve the more than 3,000 students enrolled in our College. I also hold the titles of Dean of Research and Faculty. As Dean of Research, I serve as a matchmaker for faculty seeking research partners and resources. I also manage the College's faculty development and tenure and promotion processes as Dean of Faculty. I've also had the unique opportunity to serve as Executive Associate Dean. This title has provided me with an opportunity to begin my own initiatives for the good of the College and the professions, including the creation of a diversity initiative that will create a climate and incentives for the recruitment and retention of BIPOC students, faculty, and staff.

From 2012 to 2016, I served as Director of the Division of Regional and City Planning (RCPL) at the University of Oklahoma under the leadership of Dean Charles Graham. One of the first challenges to greet me was a decision by the Planning Accreditation Board (PAB) not to reaccredit the Master's program in Regional and City Planning. Seeing a very different program than the one characterized by the Site Visit Team, I appealed the decision rendered by the Site Visit Team. The Appeals Board found that during my first year as Director of the Division many of the issues identified by the Site Visit Team been resolved. In 2015, our appeal was successful and the program was fully reaccredited. This effort required a significant effort on my part to identify deficiencies, empower stakeholders, and to build the resources necessary to shore up the program and to set it on the course for growth and expansion. In just four short years, my leadership efforts paid off and the program is on an upward trajectory today. The following is a listing of some of the fruits of my leadership of the RCPL program from 2012-2016. As a result, two new tenure track faculty members were hired to support the Division's mission. A second professor of practice was procured to support the Division's desire to engage in research and teaching related to tribal and water planning. An all alumni reunion engaged the program's 700 graduates in 2015. As a result of this capacity building effort, two student scholarships were endowed. A third endowment was given to support international travel and pro bono work through the Community Planning Studio. A new initiative was started that provided students in the RCPL program the opportunity to study abroad in Africa.

Simultaneously, I worked with a team of interdisciplinary academics across the United States to found a non-profit organization entitled the Academic Advisory Council for Signage Education and Research. I began researching the legal and planning issues related to on-premise signs in 2005. Funded by both the International Sign Association and the Signage Foundation Inc., my work with Robin Abrams, Gene Hawkins and Kimberly Geideman attracted considerable attention in the sign industry. In response to my research, I became a featured speaker at the National Signage Research and Education Conferences hosted by the University of Cincinnati and the Sign Expo. Seeking to truly engage academics who engage in sign related research, a benefactor approached me about creating an organization that could help build and disseminate peer reviewed scholarship in this field independent of strong ties to the industry. A group of scholars met at 3M in the spring of 2014 and developed a charter and a work plan. Upon creation, the benefactor issued a \$2 million endowment to support the group's first five years of activities. This includes the creation of: a peer reviewed journal, an emerging scholars development program; and an online education program. These programs will be ready for launch by January, 2017. The Journal of Signage and Visual Communications, of which I am the managing editor, has been launched and is receiving submissions for its inaugural edition.

I am and have always been an active member of the American Planning Association. I have served as the University liaison to the Florida and Oklahoma Chapters of this organization, receiving an award for service from APA-Florida in 2011. I am also an active member of the Association of Collegiate Planning Schools, elected as one of the two representatives for the Midwestern planning schools in 2016. I have presented at both national and state planning conferences, and hosted the 2014 conference of the APA-Oklahoma.
