Mariner's Court is a mixed-income, continuing care retirement community located in Annapolis, MD. Built on the pastoral edge of an historic, colonial city, Mariner's Court offers a unique blend of world-class services and amenities within the charming setting of a colonial campus. The community offers a full range of senior living options including 182 independent living units, 58 assisted living units, and 40 skilled nursing beds.

Residents have access to a variety of amenities including a walking trail, in-house movie theatre, two interior courtyards, multiple restaurants, and more.

The project is divided into two distinct components: The Commission (Phase 1) and The Regatta (Phase 2). The Commission houses the majority of the resident amenities as well as all independent and assisted living units. The Regatta houses the community's smaller amenities and skilled nursing facilities.

Together, The Commission and The Regatta offer residents a complete continuum of care within one winsome community. Mariner's Court will be the premier continuing care retirement community in the region, providing a complete senior living experience to residents from across socioeconomic groups.
