Casey Anderson

The Montgomery County Council appointed Casey Anderson to the Planning Board in 2011 and selected him to serve as chair in 2014. He also serves as chair of the Maryland-National Capital Park and Planning Commission, a bi-county agency established by state law that regulates real estate development, plans transportation infrastructure, and manages the park systems in Montgomery and Prince George's Counties.

Before assuming his current role, Anderson founded a jury consulting firm after working as a congressional staffer, government relations executive, newspaper reporter, and lawyer in private practice. He has served on the boards of several non-profit organizations, including The Washington Area Bicyclist Association, the Citizens League of Montgomery County, The Coalition to Stop Gun Violence, The Committee for Montgomery, The Woodside Civic Association, and The Silver Spring Citizens Advisory Board.

After studying law at the University of Vienna, he started his career as a legal advisor at the 'Mietervereinigung Österreichs' – the largest non-profit-organization for tenant's rights in Austria. In 2000, the Vienna City Counselor for Housing asked Josef to join his team as an advisor focusing on housing law and social issues. In 2009, Josef was given the go-ahead to set up an organization, associated with the City of Vienna, focusing on conflict management and improving community relations within Vienna's municipal social housing properties. Several months later 'wohnpartner' was founded, which Josef has run with great success until now. Just recently Josef has been appointed by the mayor of Vienna as designated Director of "Wohnservice Wien", the umbrella association of the City of Vienna, dealing with all relevant housing questions.



Casey Dawkins

Professor of Urban Studies and Planning, Director of the Urban Studies and Planning and Urban and Regional Planning and Design Programs, and Affiliate of the National Center for Smart Growth at the University of Maryland.

His current research focuses on U.S. housing policy evaluation; housing justice; the causes, consequences, and measurement of residential segregation by race and income; and the link between land use regulations and housing affordability. He has written two books and over 50 refereed journal articles and book chapters on these topics. Dr. Dawkins currently serves on the editorial advisory boards of the Journal of the American Planning Association and Housing Policy Debate.

Eisenbach's work has explored the loss of home after foreclosure, our relationship to water, and bringing people together across difference. She was recognized by Project Anywhere for Placeholders (2014) which examined what it means to seek, shape, and preserve a place on a site in-flux. Eisenbach co-authored Installations by Architects: Experiments in Building and Design (2009) and Ruth Adler Schnee: A Passion for Color (2011).

Gerrit-Jan Knaap is Professor of Urban Studies and Planning, Executive Director of the National Center for Smart Growth Research at the University of Maryland. Knaap earned his B.S. from Willamette University, his M.A. and Ph.D. from the University of Oregon, and received post-doctoral training at the University of Wisconsin-Madison, all in economics. Knaap’s research interests include the interactions between housing markets and policy, the economics and politics of land use planning, the efficacy of economic development instruments, and the impacts of environmental policy. On these subjects, Knaap has authored or coauthored over 65 articles in peer refereed journals, and coauthored or co-edited nine books. Funding for his research has been provided by the National Science Foundation, the Lincoln Institute of Land Policy, the Town Creek foundation, and numerous other federal, state, and local government agencies. He currently serves on the State of Maryland’s Smart Growth Subcabinet, Sustainable Growth Commission, Governor’s Scientific Advisory Panel, and the Mitigation and Science workgroups of the Climate Commission.
